

# PRIVACY POLICY

(Updated as of 2 February, 2018)

DLI Market Deals L.T.D. is committed to protecting your privacy. We have prepared this Privacy Policy to describe to you our practices regarding the Personal Information (E-mail address, Cryptocurrency address) we collect from users of our website, located at <https://mobzoid.world> and online services.

## What Information Do We Collect?

This includes any personal information that you give us by filling in forms on the Website or by corresponding with us by e-mail. It also includes information you provide when you register to use our Website, subscribe to our service, participate in discussion boards or other social media functions on our site, contribute to any Token Sale (as defined in the terms of our Token Sale) and when you report a problem with our site. The information you give us may include your e-mail address, crypto-wallets addresses and any other personal data provided to us.

## What is Personal Information?

## COOKIES

Our website uses cookies. A cookie is a small file of letters and numbers that we put on your computer if you agree. These cookies allow us to distinguish you from other users of our website, which helps us to provide you with a good experience when you browse our website and allows us to improve our website. The cookies we use are session or time-based. However, if you wish you can change your cookie settings in your browser like to prevent any cookies being stored on your online enabled device, but be aware that this may severely impact the functionality of the site. Please note that third parties (including, for example, advertising networks and providers of external services like web traffic analysis services) may also use cookies, over which we have no control. These cookies are likely to be analytical/performance cookies or targeting cookies.

## USES OF THE INFORMATION
